DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and LAS MINAS DE ORO CONSTRUCTION with office address in Sta. Maria Village, Calapan City, Oriental Mindoro represented by EVELYN A. ABAS, Proprietress, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Concreting of Road at Ranzo, Pinamalayan, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE HUNDRED NINETY NINE THOUSAND FORTY EIGHT PESOS AND 60/100 ONLY (Php 999,048.60) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
