DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and SOSEP BUILDERS with office address at Campaasan, Bulalacao, Oriental Mindoro represented by ENGR. ERNESTO C. VILLAS, JR., Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Repair/ Improvement of Day Care Center w/ Recreational Playground at Inclanay, Pinamalayan, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount SEVEN HUNDRED EIGHTY SEVEN THOUSAND ONE HUNDRED FIFTY SIX PESOS AND 33/100 ONLY (Php 787,156.33) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
