BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT (INFRASTRUCTURE)

Resolution No. 078, Series of 2022

WHEREAS, there is an infrastructure project funded through the 20% DF-CA FY 2021 to be undertaken by the Provincial Government of Oriental Mindoro for the Completion of Health Center at Bukal Bongabong, Oriental Mindoro and Completion of Multi-Purpose Building at Luna, Bongabong, Oriental Mindoro (Completion of Health Center (9mx6m) Tileworks of existing building (54 sq.m including counter on pantry) and Cabinet (pantry area and office area) Dirty Kitchen at the back (5mx2m) with roofing, plumbing, electrical, tiles, paintings, doors, and windows. Door (2.10mx0.80m), Windows (2-0.60mx0.50m & 1.80mx1.20m)./ Completion of Mullti-Purpose Building (6.0mx9.0m) Grills, Cabinets, Painting Works, and Signage);

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2022-045-A) in PhilGEPS Website on March 02, 2022 and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the Completion of Health Center at Bukal Bongabong, Oriental Mindoro and Completion of Multi-Purpose Building at Luna, Bongabong, Oriental Mindoro (Completion of Health Center (9mx6m) Tileworks of existing building (54 sq.m including counter on pantry) and Cabinet (pantry area and office area) Dirty Kitchen at the back (5mx2m) with roofing, plumbing, electrical, tiles, paintings, doors, and windows. Door (2.10mx0.80m), Windows (2-0.60mx0.50m & 1.80mx1.20m)./ Completion of Mullti-Purpose Building (6.0mx9.0m) Grills, Cabinets, Painting Works, and Signage);

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. SGDG CONSTRUCTION AND SUPPLIES

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on March 11, 2022, the bids were received until 8:30 am and opened thereafter in accordance with the provisions of R.A. 9184 otherwise known as "Government Procurement Reform Act and its Implementing Rules and Regulations";

WHEREAS, during the opening of Bid on **March 11**, **2022** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **SGDG CONSTRUCTION AND SUPPLIES** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:

WHEREAS, the detailed evaluation of bids conducted on March 11, 2022 found out that bid price of SGDG CONSTRUCTION AND SUPPLIES is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the Single Calculated Bid;

WHEREAS, upon careful examination, validation and verification of eligibility, technical, financial requirements submitted by SGDG CONSTRUCTION AND SUPPLIES with Single Calculated Bid, its bid passed the post qualification process conducted on March 14, 2022, thereby making its bid found to be responsive;
