## CONTRACT AGREEMENT

MAR 1 1 2022 THIS AGREEMENT, made this between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and 876 CONSTRUCTION & SUPPLY with office address at Malamig. Calapan City, Oriental Mindoro represented by ROBERTO B. YLAGAN, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Installation of Solar Panel at Pakpaklawin ES, Gloria, Oriental Mindoro and Construction of Covered Pathwalk at Pambisan Malaki ES, Pinamalayan, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount FOUR HUNDRED FORTY EIGHT THOUSAND FOUR HUNDRED TWENTY FIVE PESOS AND 10/100 ONLY (Php 448,425.10) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
