CONTRACT AGREEMENT

THIS AGREEMENT, made this MAR 11 2022 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and B5 BUILDERS & SUPPLIES with office address at Libis, Calapan City, Oriental Mindoro represented by BERNARDO O. APACIBLE, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Improvement of Gabaldon Bldg. at Oriental Mindoro NHS, Calapan City, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE HUNDRED NINETY FOUR THOUSAND NINE HUNDRED NINETY SIX PESOS AND 65/100 ONLY (Php 994,996.65) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
