BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT (INFRASTRUCTURE)

Resolution No. 040, Series of 2022

WHEREAS, there is an infrastructure project funded through the SEF CA FY 2021 to be undertaken by the Provincial Government of Oriental Mindoro for the Completion of Gymnasium at San Mariano NHS, Roxas, Oriental Mindoro (Completion of Roofing and Roof Framing, Installation of Roofing Accessories);

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2022-048) in PhilGEPS Website on February 12, 2022 and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the Completion of Gymnasium at San Mariano NHS, Roxas, Oriental Mindoro (Completion of Roofing and Roof Framing, Installation of Roofing Accessories);

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. RJJJ ENGINEERING SERVICES

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on February 21, 2022, the bids were received until 8:30 am and opened thereafter in accordance with the provisions of R.A. 9184 otherwise known as "Government Procurement Reform Act and its Implementing Rules and Regulations":

WHEREAS, during the opening of Bid on February 21, 2022 eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by RJJJ ENGINEERING SERVICES was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:

WHEREAS, the detailed evaluation of bids conducted on February 21, 2022 found out that bid price of RJJJ ENGINEERING SERVICES is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the Single Calculated Bid;
