CONTRACT AGREEMENT

THIS AGREEMENT, made this <u>MAR 1 1 2022</u> between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and RJJJ ENGINEERING SERVICES with office address 030 Purok I, Brgy. San Agustin I, Naujan, Oriental Mindoro represented by JOHN CROMWELL D. RECTO, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Completion of Gymnasium at San Mariano NHS, Roxas, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE HUNDRED SIXTY TWO THOUSAND NINE HUNDRED SIXTY FIVE PESOS AND 50/100 (Php 962,965.50) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
