RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT
(INFRASTRUCTURE)**

WHEREAS, there is an infrastructure project funded through the **20% DF CA FY 2021** to be undertaken by the Provincial Government of Oriental Mindoro for the **Construction of Drainage Canal at So. Looban, Lumangbayan, Calapan City, Oriental Mindoro (Drainage Canal: Source of Aggregates: Tigkan River, Station Limit 1 0+000.00-0+016.00, Station Limit 2 0+020.00-0+060.00, Station Limit 3 0+060.00-0+102.00, Depth 1&2=0.55m, Depth 3=0.75m, Width=0.60m, Total Length=98.00m)**;

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2022-051) in PhilGEPS Website on **February 19, 2022** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Construction of Drainage Canal at So. Looban, Lumangbayan, Calapan City, Oriental Mindoro (Drainage Canal: Source of Aggregates: Tigkan River, Station Limit 1 0+000.00-0+016.00, Station Limit 2 0+020.00-0+060.00, Station Limit 3 0+060.00-0+102.00, Depth 1&2=0.55m, Depth 3=0.75m, Width=0.60m, Total Length=98.00m)**;

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. RADEL CONSTRUCTION

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **February 28, 2022**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

WHEREAS, during the opening of Bid on **February 28, 2022** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **RADEL CONSTRUCTION** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:
