CONTRACT AGREEMENT

THIS AGREEMENT, made this MAR 11 2022 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and RADEL CONSTRUCTION with office address along C-5 Road, Sta. Isabel, Calapan City, Oriental Mindoro represented by ENGR. ADELFA P. PEREZ, Proprietress, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Drainage Canal at So. Looban, Lumangbayan, Calapan City, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount FIVE HUNDRED TWENTY ONE THOUSAND FIVE HUNDRED TWELVE PESOS AND 44/100 ONLY (Php 521,512.44) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
