## CONTRACT AGREEMENT

THIS AGREEMENT, made this MAR 1 1 2022 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and WEBUILD CONSTRUCTION with office address at Bagumbayan, Roxas, Oriental Mindoro represented by CHRISTOPHER Y. CARVAJAL, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Completion of Multi-Purpose Building at Sigange, Bongabong, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE HUNDRED NINETY FOUR THOUSAND EIGHT HUNDRED NINE PESOS AND 58/100 ONLY (Php 994,809.58) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
