Completion of Multi-Purpose Building at Sigange, Bongabong, Oriental Mindoro

- 1. The Provincial Government of Oriental Mindoro (PGOM) through the 20% DF CA FY 2021 intends to apply the sum of Nine Hundred Ninety Five Thousand Four Hundred Eighty Four Pesos and 61/100 Only (Php_995,484.61) being the approved Budget for the Contract (ABC) to payment under the contract for "Completion of Multi-Purpose Building at Sigange, Bongabong, Oriental Mindoro". Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PGOM now invites bids for "Completion of Multi-Purpose Building at Sigange, Bongabong, Oriental Mindoro". Completion of the Works is 45 calendar days. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
