Completion of Multi-Purpose Building at Sigange, Bongabong, Oriental Mindoro

1. The **Provincial Government of Oriental Mindoro (PGOM)** through the **20% DF CA FY 2021** intends to apply the sum of **Nine Hundred Ninety Five Thousand Four Hundred Eighty Four Pesos and 61/100 Only (Php 995,484.61)** being the approved Budget for the Contract (ABC) to payment under the contract for **"Completion of Multi-Purpose Building at Sigange, Bongabong, Oriental Mindoro"**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The PGOM now invites bids for **"Completion of Multi-Purpose Building at Sigange, Bongabong, Oriental Mindoro"**. Completion of the Works is **45 calendar days**. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
