## Completion of Barangay Hall at Nabuslot, Pinamalayan, Oriental Mindoro

- 1. The Provincial Government of Oriental Mindoro (PGOM) through the General Fund CA FY 2021 intends to apply the sum of Seven Hundred Ninety Nine Thousand One Hundred One Pesos and 16/100 Only (Php 799,101.16) being the approved Budget for the Contract (ABC) to payment under the contract for "Completion of Barangay Hall at Nabusiot, Pinamalayan, Oriental Mindoro". Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PGOM now invites bids for "Completion of Barangay Hall at Nabuslot, Pinamalayan, Oriental Mindoro". Completion of the Works is 22 calendar days. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
