Construction of Evacuation Center at Brgy. Poblacion, Mansalay, Oriental Mindoro

- 1. The Provincial Government of Oriental Mindoro (PGOM) through the 5% LDRRMF CA FY 2021 intends to apply the sum of Nine Hundred Ninety Eight Thousand Six Hundred Seventy Six Pesos and 68/100 Only (Php 998,676.68) being the approved Budget for the Contract (ABC) to payment under the contract for "Construction of Evacuation Center at Brgy. Poblacion, Mansalay, Oriental Mindoro". Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PGOM now invites bids for "Construction of Evacuation Center at Brgy. Poblacion, Mansalay, Oriental Mindoro". Completion of the Works is 37 calendar days. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
