Completion of Covered Court of Aurelio Arago MNHS, Alcate Annex, Victoria, Oriental Mindoro

- 1. The Provincial Government of Oriental Mindoro (PGOM) through the SEF CA FY 2021 intends to apply the sum of Nine Hundred Eighty Nine Thousand Two Hundred Twenty One Pesos and 66/100 Only (Php 989,221.66) being the approved Budget for the Contract (ABC) to payment under the contract for "Completion of Covered Court of Aurelio Arago MNHS, Alcate Annex, Victoria, Oriental Mindoro". Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PGOM now invites bids for "Completion of Covered Court of Aurelio Arago MNHS, Alcate Annex, Victoria, Oriental Mindoro". Completion of the Works is 34 calendar days. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
