CONTRACT AGREEMENT

THIS AGREEMENT, made this MAR 15 2022 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and JOHNSEV ENTERPRISES with office address at Campaasan, Bulalacao, Oriental Mindoro represented by NELSON S. BANTUGAN, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Solar Drier at Sitio Bool, Milagrosa, Bulalacao, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE HUNDRED EIGHTY SEVEN THOUSAND TWO HUNDRED NINETY ONE PESOS AND 35/100 ONLY (Php 987,291.35) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
