CONTRACT AGREEMENT

THIS AGREEMENT, made this MAR 15 2022 between **PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO**, Camilmil, Calapan City, Oriental Mindoro, represented by **HUMERLITO A. DOLOR, MPA, Ph.D.**, Provincial Governor hereinafter called the "ENTITY" and **SHANLEY CONSTRUCTION** with office address at Carreon St. Centro East, Santiago City, Isabela represented by **PATRICK A. TAGUINOD**, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the **Construction of Footbridge at So. Riverside, Personas, Calapan City, Oriental Mindoro**, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount **TWO MILLION NINE HUNDRED TWENTY SEVEN THOUSAND FIVE PESOS AND 74/100 ONLY (Php 2,927,005.74)** by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - F. PERT/CPM Diagram and bar chart with S-curve.
 - G. Other documentary requirements
 1. Equipment Utilization Schedule
 2. Manpower Utilization Schedule

 4. Construction Schedule and S-Curve
