## **CONTRACT AGREEMENT**

THIS AGREEMENT, made this MAR 1 5 2022 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and RADEL CONSTRUCTION with office address along C-5 Road, Sta. Isabel, Calapan City, Oriental Mindoro represented by ENGR. ADELFA P. PEREZ, Proprietress, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Improvement of Multi-Purpose Building at Aninuan, Puerto Galera, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount TWO MILLION FOUR HUNDRED EIGHTY NINE THOUSAND NINE HUNDRED FORTY THREE PESOS AND 75/100 ONLY (Php 2,489,943.75) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
