BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT (INFRASTRUCTURE)

Resolution No. 058, Series of 2022

WHEREAS, there is an infrastructure project funded through the SEF CA FY 2021 to be undertaken by the Provincial Government of Oriental Mindoro for the Construction of Multi Purpose Hall w/ Mini Bridge at Nag-lba II NHS, Calapan City, Oriental Mindoro (Construction of 2nd floor of stage and mini bridges connecting to 1 building. Not including ceiling, fascia cover & framing, gutter and downspout; Embankment to be shouldered by PGOM mechanized units. (H=0.33m);

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2022-062) in PhilGEPS Website on February 14, 2022 and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the Construction of Multi Purpose Hall w/ Mini Bridge at Nag-Iba II NHS, Calapan City, Oriental Mindoro (Construction of 2nd floor of stage and mini bridges connecting to 1 building. Not including ceiling, fascia cover & framing, gutter and downspout; Embankment to be shouldered by PGOM mechanized units. (H=0.33m);

WHEREAS, in response to the said advertisement, one (1) prospective bidder/contractor submitted application for eligibility and purchased bid documents;

1. ZOE BUILDERS AND SUPPLIES COMPANY

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on March 07, 2022, the bids were received until 8:30 am and opened thereafter in accordance with the provisions of R.A. 9184 otherwise known as "Government Procurement Reform Act and its Implementing Rules and Regulations";

WHEREAS, during the opening of Bid on March 07, 2022 eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **ZOE BUILDERS AND SUPPLIES COMPANY** was **examined and** found substantially complied with the technical and financial proposals, thereby making the bid **proposals passed** the preliminary examination of bid as the bid price read out as:
