DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and GREEN ISLAND ENTERPRISES with office address at Maligaya, Gloria, Oriental Mindoro represented by JOANNE D. ENRIQUEZ, Proprietress, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Improvement of Barangay Hall at Bagong Bayan I, Bongabong, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount ONE MILLION NINE HUNDRED EIGHTY SEVEN THOUSAND FIVE HUNDRED TWENTY FIVE PESOS AND 04/100 (Php 1,987,525.04) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
