MAR 1 5 2022 THIS AGREEMENT, made this between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and MHARPHY CONSTRUCTION AND SUPPLY with office address at San Aquilino, Roxas, Oriental Mindoro represented by MARIO S. PEREZ, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Hagan Road Leading to Humindang Cave, Bongabong, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount TWO MILLION FOUR HUNDRED NINETY ONE THOUSAND SEVEN HUNDRED FOURTEEN PESOS AND 55/100 ONLY (Php 2,491,714.55) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
