## Construction of Hagan Road leading to Humindang Cave, Bongabong, Or. Mindoro

- 1. The Provincial Government of Oriental Mindoro (PGOM) through the 20% DF CA FY 2021 intends to apply the sum of Two Million Four Hundred Ninety Four Thousand Three Hundred Seven Pesos and 91/100 Only (Php 2,494,307.91) being the Approved Budget for the Contract (ABC) to payment under the contract for "Construction of Hagan Road leading to Humindang Cave, Bongabong, Or. Mindoro". Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PGOM now invites bide for "Construction of Hagan Road leading to Humindang Cave, Bongabong, Or. Mindoro". Completion of the Works is 55 calendar days. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
