## CONTRACT AGREEMENT

THIS AGREEMENT, made this MAR 1 5 2022 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and WTL CONSTRUCTION with office address Manilo St., Mansalay, Oriental Mindoro represented by RENATO T. DE LARA, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Water System at Brgy. Sto. Niño, Pinamalayan, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount THREE MILLION EIGHT HUNDRED TWENTY TWO THOUSAND NINE HUDNRED THIRTY FIVE PESOS AND 40/100 (Php 3,822,935.40) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
