Construction of Water System at Brgy. Sto. Niño, Pinamalayan, Oriental Mindoro

1. The Provincial Government of Oriental Mindoro (PGOM) through the 20% DF CA FY 2021 intends to apply the sum of **Three Million Eight Hundred Twenty Five Thousand Nine Hundred Sixty One Pesos and 31/100 Only (Php 3,825,961.31)** being the Approved Budget for the Contract (ABC) to payment under the contract for "**Construction of Water System at Brgy. Sto. Niño, Pinamalayan, Oriental Mindoro**". Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The PGOM now invites bids for "**Construction of Water System at Brgy. Sto. Niño, Pinamalayan, Oriental Mindoro**". Completion of the Works is **78 calendar days**. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
