CONTRACT AGREEMENT

THIS AGREEMENT, made this MAR 15 2022 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and SHANLEY CONSTRUCTION with office address at Carreon St. Centro East, Santiago City, Isabela represented by PATRICK A. TAGUINOD, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Evacuation Center at Brgy. San Ignacio, Baco, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount THREE MILLION NINE HUNDRED NINETY FIVE THOUSAND EIGHT HUNDRED SEVENTY EIGHT PESOS AND 92/100 ONLY (Php 3,995,878.92) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
