**BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND
RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT
(INFRASTRUCTURE)**

Resolution No. 081, Series of 2022

WHEREAS, there is an infrastructure project funded through the **LGSF-DRRP 2021** to be undertaken by the Provincial Government of Oriental Mindoro for the **Construction of Drying Facility at Naujan, Oriental Mindoro (Construction of 8.0m x 14.0m Drying Facility. Embankment (H=1.00m);**

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2022-083) in PhilGEPS Website on **February 18, 2022** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Construction of Drying Facility at Naujan, Oriental Mindoro (Construction of 8.0m x 14.0m Drying Facility. Embankment (H=1.00m);**

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. RJJJ ENGINEERING SERVICES

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **March 11, 2022**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

WHEREAS, during the opening of Bid on **March 11, 2022** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **RJJJ ENGINEERING SERVICES** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:

WHEREAS, the detailed evaluation of bids conducted on **March 11, 2022** found out that bid price of **RJJJ ENGINEERING SERVICES** is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the **Single Calculated Bid**;

WHEREAS, upon careful examination, validation and verification of eligibility, technical, financial requirements submitted by **RJJJ ENGINEERING SERVICES** with **Single Calculated Bid**, its bid passed the post qualification process conducted on **March 14, 2022**, thereby making its bid found to be responsive;
