CONTRACT AGREEMENT

THIS AGREEMENT, made this MAR 22 2022 between **PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO**, Camilmil, Calapan City, Oriental Mindoro, represented by **HUMERLITO A. DOLOR, MPA, Ph.D.**, Provincial Governor hereinafter called the "ENTITY" and **RJJJ ENGINEERING SERVICES** with office address 030 Purok I, Brgy. San Agustin I, Naujan, Oriental Mindoro represented by **JOHN CROMWELL D. RECTO**, Authorized Managing Officer, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the **Construction of Drying Facility at Naujan, Oriental Mindoro**, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount **ONE MILLION NINE HUNDRED EIGHTY SIX THOUSAND FOUR HUNDRED FIFTY FIVE PESOS AND 20/100 (Php 1,986,455.20)** by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
