CONTRACT AGREEMENT

THIS AGREEMENT, made this MAR 22 2022 between **PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO**, Camilmil, Calapan City, Oriental Mindoro, represented by **HUMERLITO A. DOLOR, MPA, Ph.D.**, Provincial Governor hereinafter called the "ENTITY" and **ADL CONSTRAK** with office address at Bagumbayan, Roxas, Oriental Mindoro represented by **ALEX D. LAQUI**, Authorized Managing Officer, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the **Improvement of Water System, San Isidro, Bulalacao, Oriental Mindoro**, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount **TWO MILLION NINE HUNDRED EIGHTY SEVEN THOUSAND SEVEN HUNDRED SIXTY ONE PESOS AND 50/100 ONLY (Php 2,987,761.50)** by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

 - B. Bid Form including its Eligibility/Technical Proposals and Financial Proposals, with addendum showing corrections, if any, made during the Bid Evaluation to arrive at the Calculated Bid.
 - C. Notice of Award of Contract and the Contractor's "Conforme" thereon.
 - D. Performance Security
 - E. Credit Line or Net Financial Contracting Capacity.
 - F. PERT/CPM Diagram and bar chart with S-curve.
 - G. Other documentary requirements
 1. Equipment Utilization Schedule
 2. Manpower Utilization Schedule
 3. Construction Method
 4. Construction Schedule and S-Curve
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.

The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
