CONTRACT AGREEMENT

THIS AGREEMENT, made this MAR 2 2 2022 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and MARCPHIL CONSTRUCTION with office address at San Aquilino, Roxas, Oriental Mindoro represented by MARCIANO M. DIMAPILIS, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Improvement of Water System, Nasucob, Bulalacao, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount SIX MILLION NINE HUNDRED NINETY TWO THOUSAND THREE HUNDRED TEN PESOS AND 05/100 ONLY (Php 6,992,310.05) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

 - D. Performance Security
 - E. Credit Line or Net Financial Contracting Capacity.
 - F. PERT/CPM Diagram and bar chart with S-curve.
 - G. Other documentary requirements
 - 1. Equipment Utilization Schedule
 - 2. Manpower Utilization Schedule
 - Construction Method
 - 4. Construction Schedule and S-Curve
