**BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND
RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT
(INFRASTRUCTURE)**

Resolution No. 083, Series of 2022

WHEREAS, there is an infrastructure project funded through the **General Fund CA-FY 2021** to be undertaken by the Provincial Government of Oriental Mindoro for the **Construction of Tourist Assistance Center at Sitio Pocanil, San Roque, Bulalacao, Oriental Mindoro (Construction of 6.00m x 4.00m tourist assistance center with reinforced concrete works, masonry works, roofing works, electrical works, painting works, tile works (at Cr floor and walls only), doors and windows, plumbing works & septic vault. (Embankment –PGOM Counterpart);**

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2022-089) in PhilGEPS Website on **March 02, 2022** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Construction of Tourist Assistance Center at Sitio Pocanil, San Roque, Bulalacao, Oriental Mindoro (Construction of 6.00m x 4.00m tourist assistance center with reinforced concrete works, masonry works, roofing works, electrical works, painting works, tile works (at Cr floor and walls only), doors and windows, plumbing works & septic vault. (Embankment –PGOM Counterpart);**

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. WTL CONSTRUCTION

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **March 11, 2022**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

WHEREAS, during the opening of Bid on **March 11, 2022** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **WTL CONSTRUCTION** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:

WHEREAS, the detailed evaluation of bids conducted on **March 11, 2022** found out that bid price of **WTL CONSTRUCTION** is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the **Single Calculated Bid**;

WHEREAS, upon careful examination, validation and verification of eligibility, technical, financial requirements submitted by **WTL CONSTRUCTION** with **Single Calculated Bid**, its bid passed the post qualification process conducted on **March 14, 2022**, thereby making its bid found to be responsive;
