CONTRACT AGREEMENT

THIS AGREEMENT, made this MAR 2 2 2022 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and WTL CONSTRUCTION with office address Manilo St., Mansalay, Oriental Mindoro represented by RENATO T. DE LARA, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Tourist Assistance Center at Sitio Pocanil, San Roque, Bulalacao, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE HUNDRED NINETY SIX THOUSAND NINE HUNDRED NINETY SIX PESOS AND 21/100 (Php 996,996.21) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - E. Credit Line or Net Financial Contracting Capacity.
 - F. PERT/CPM Diagram and bar chart with S-curve.
 - G. Other documentary requirements

 - 2. Manpower Utilization Schedule
