CONTRACT AGREEMENT

THIS AGREEMENT, made this MAR 22 2022 between **PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO**, Camilmil, Calapan City, Oriental Mindoro, represented by **HUMERLITO A. DOLOR, MPA, Ph.D.**, Provincial Governor hereinafter called the "ENTITY" and **WTL CONSTRUCTION** with office address Manilo St., Mansalay, Oriental Mindoro represented by **RENATO T. DE LARA**, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the **Construction of Tourist Assistance Center at Sitio Pocanil, San Roque, Bulalacao, Oriental Mindoro**, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount **NINE HUNDRED NINETY SIX THOUSAND NINE HUNDRED NINETY SIX PESOS AND 21/100 (Php 996,996.21)** by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - F. PERT/CPM Diagram and bar chart with S-curve.
