BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT (INFRASTRUCTURE)

Resolution No. 084, Series of 2022

WHEREAS, there is an infrastructure project funded through the General Fund CA-FY 2021 to be undertaken by the Provincial Government of Oriental Mindoro for the Construction of PG-ENRO Checkpoint Stations in Strategic Location, Oriental Mindoro and Repair of PG-ENRO Checkpoint Stations in Strategic Location, Oriental Mindoro (Construction of 3 units Outpost; Note: Ceiling Works of this Construction includes at the "Repair of PG ENRO checkpoint stations in Strategic Locations"/ Repair of 6 units PG-ENRO checkpoints. (San Isidro, Bongabong, Sto. Niño, Pinamalayan, Bucayao, Calapan City, Narra, Gloria, Mansalay and Roxas) Note: Materials & labor of ceiling for construction of 3 units PG-ENRO checkpoint are included in this POW);

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2022-090) in PhilGEPS Website on March 02, 2022 and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the Construction of PG-ENRO Checkpoint Stations in Strategic Location, Oriental Mindoro (Construction of 3 units Outpost; Note: Ceiling Works of this Construction includes at the "Repair of PG ENRO checkpoint stations in Strategic Locations"/ Repair of 6 units PG-ENRO checkpoints. (San Isidro, Bongabong, Sto. Niño, Pinamalayan, Bucayao, Calapan City, Narra, Gloria, Mansalay and Roxas) Note: Materials & labor of ceiling for construction of 3 units PG-ENRO checkpoint are included in this POW);

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. 811 TRADING AND CONSTRUCTION

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on March 11, 2022, the bids were received until 8:30 am and opened thereafter in accordance with the provisions of R.A. 9184 otherwise known as "Government Procurement Reform Act and its Implementing Rules and Regulations";

WHEREAS, during the opening of Bid on **March 11**, **2022** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **811 TRADING AND CONSTRUCTION** was examined and **found substantially** complied with the technical and financial proposals, thereby making the bid proposals passed **the preliminary** examination of bid as the bid price read out as:

WHEREAS, the detailed evaluation of bids conducted on March 11, 2022 found out that bid price of 811 TRADING AND CONSTRUCTION is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the Single Calculated Bid;
