CONTRACT AGREEMENT

THIS AGREEMENT, made this MAR 22 2022 between **PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO**, Camilmil, Calapan City, Oriental Mindoro, represented by **HUMERLITO A. DOLOR, MPA, Ph.D.**, Provincial Governor hereinafter called the "ENTITY" and **811 TRADING AND CONSTRUCTION** with office address at 9 Palayan St., Paclasán, Roxas, Oriental Mindoro represented by **ENGR. ARMIN C. SUZARA**, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the **Construction of PG-ENRO Checkpoint Stations in Strategic Locations, Oriental Mindoro and Repair of PG-ENRO Checkpoint Stations in Strategic Locations, Oriental Mindoro**, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount **FIVE HUNDRED NINETY EIGHT THOUSAND NINE HUNDRED SEVENTY NINE PESOS AND 98/100 ONLY (Php 598,979.98)** by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
