**BAC RESOLUTION DECLARING LOWEST CALCULATED RESPONSIVE BID (LCRB) AND
RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT
(INFRASTRUCTURE)**

Resolution No. 099, Series of 2022

WHEREAS, there is an infrastructure project funded through the **General Fund CA FY 2021** to be undertaken by the Provincial Government of Oriental Mindoro for the **Construction of Mangyan Heritage, Mansalay, Oriental Mindoro (Construction of Performance Area: Area=804.24 sq.m; Construction of 3 units of Workshop: Area=176.7 sq.m; Including: landscaping, Cut & Fill, Stone Masonry, Grouted Riprap, Stairs & Railings, Ramp and Bleachers; Sand & Gravel Hauling dist.=29km (ORCUNOMA RIVER) Embankment Hauling dist.=minimum (CAGANCAN RIVER);**

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2022-091) in PhilGEPS Website on **February 23, 2022** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Construction of Mangyan Heritage, Mansalay, Oriental Mindoro (Construction of Performance Area: Area=804.24 sq.m; Construction of 3 units of Workshop: Area=176.7 sq.m; Including: landscaping, Cut & Fill, Stone Masonry, Grouted Riprap, Stairs & Railings, Ramp and Bleachers; Sand & Gravel Hauling dist.=29km (ORCUNOMA RIVER) Embankment Hauling dist.=minimum (CAGANCAN RIVER);**

WHEREAS, in response to the said advertisement, **two (2) prospective bidders/contractors** submitted application for eligibility and purchased bid documents;

- 1. ADL CONSTRAK**
- 2. WTL CONSTRUCTION**

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **March 16, 2022**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

WHEREAS, during the opening of Bid on **March 16, 2022** eligibility check was conducted to two (2) bidders/contractors mentioned above and were found eligible by the BAC;

WHEREAS, all bid proposals submitted during the opening of bid were examined and found substantially complied with the technical and financial proposals, thereby making all bid proposals passed the preliminary examination of bid as their corresponding bid price read out as follows.

WHEREAS, the detailed evaluation and comparison of bids conducted on **March 16, 2022** found out that bid price of **ADL CONSTRAK** is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the **Lowest Calculated Bid**;
