## **CONTRACT AGREEMENT**

MAR 2 4 2022 THIS AGREEMENT, made this between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and ADL CONSTRAK with office address at Bagumbayan, Roxas, Oriental Mindoro represented by ALEX D. LAQUI, Authorized Managing Officer, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Mangyan Heritage, Mansalay, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount FOURTEEN MILLION NINE HUNDRED SEVENTEEN THOUSAND SEVEN HUNDRED NINETEEN PESOS AND 17/100 ONLY (Php 14,917,719.17) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
