THIS AGREEMENT, made this MAR 24 2022 between **PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO**, Camilmil, Calapan City, Oriental Mindoro, represented by **HUMERLITO A. DOLOR, MPA, Ph.D.**, Provincial Governor hereinafter called the "ENTITY" and **WTL CONSTRUCTION** with office address Manilo St., Mansalay, Oriental Mindoro represented by **RENATO T. DE LARA**, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the **Construction of Tourism Lodges at Sitio Pocanil, San Roque, Bulalacao, Oriental Mindoro**, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount **TWO MILLION NINE HUNDRED EIGHTY FOUR THOUSAND NINE HUNDRED SIXTY FIVE PESOS AND 75/100 (Php 2,984,965.75)** by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
