(INFRASTRUCTURE)**

WHEREAS, there is an infrastructure project funded through the **Special Education Fund 2022** to be undertaken by the Provincial Government of Oriental Mindoro for the **Completion of Sports Complex Phase III, Santiago, Naujan, Oriental Mindoro (-)**;

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2022-093) in PhilGEPS Website on **February 25, 2022** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Completion of Sports Complex Phase III, Santiago, Naujan, Oriental Mindoro (-)**;

WHEREAS, in response to the said advertisement, **two (2) prospective bidders/contractors** submitted application for eligibility and purchased bid documents;

- 1. SANLAHI GROUP OF BUILDERS, INC.**
- 2. B5 BUILDERS AND SUPPLIES**

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **March 18, 2022**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

WHEREAS, during the opening of Bid on **March 18, 2022** eligibility check was conducted to two (2) bidders/contractors mentioned above and were found eligible by the BAC;

WHEREAS, all bid proposals submitted during the opening of bid were examined and found substantially complied with the technical and financial proposals, thereby making all bid proposals passed the preliminary examination of bid as their corresponding bid price read out as follows.
