**BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND  
 RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT  
 (INFRASTRUCTURE)**

**Resolution No. 102, Series of 2022**

**WHEREAS**, there is an infrastructure project funded through the 20% DF-CA FY 2021 to be undertaken by the Provincial Government of Oriental Mindoro for the **Construction of Reservoir/Water Intake Dam at Brgy. Buong Lupa, Gloria, Oriental Mindoro (7 pcs. G.I. Pipe 4"Ø, 2 pcs G.I. Pipe 3"Ø, 2 pcs G.I. Pipe 2 ½" Ø, 2 pcs G.I. Pipe 2" Ø, HDPE Pipe 2" Ø, HDPE Pipe 1 ½" Ø & HDPE Pipe 1 ¼"Ø HDPE Pipe 1"Ø, HDPE Pipe ½" Ø (to households) with 2 faucet per HH and SCH Plaster Finish (inside & outside) of Reservoir);**

**WHEREAS**, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2022-094) in PhilGEPS Website on **February 25, 2022** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Construction of Reservoir/Water Intake Dam at Brgy. Buong Lupa, Gloria, Oriental Mindoro (7 pcs. G.I. Pipe 4"Ø, 2 pcs G.I. Pipe 3"Ø, 2 pcs G.I. Pipe 2 ½" Ø, 2 pcs G.I. Pipe 2" Ø, HDPE Pipe 2" Ø, HDPE Pipe 1 ½" Ø & HDPE Pipe 1 ¼"Ø HDPE Pipe 1"Ø, HDPE Pipe ½" Ø (to households) with 2 faucet per HH and SCH Plaster Finish (inside & outside) of Reservoir);**

**WHEREAS**, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

**1. SOSEP BUILDERS**

**WHEREAS**, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **March 18, 2022**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

**WHEREAS**, during the opening of Bid on **March 18, 2022** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

**WHEREAS**, the bid proposals submitted by **SOSEP BUILDERS** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:
