## **CONTRACT AGREEMENT**

MAR 2 3 2022 THIS AGREEMENT, made this between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and SOSEP BUILDERS with office address at Campaasan, Bulalacao, Oriental Mindoro represented by ENGR. ERNESTO C. VILLAS, JR., Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Reservoir/ Water Intake Dam at Brgy. Buong Lupa, Gloria, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount THREE MILLION SIX HUNDRED NINETY FIVE THOUSAND FOUR HUNDRED FORTY NINE PESOS AND 40/100 ONLY (Php 3,695,449.40) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
