**BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND
RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT
(INFRASTRUCTURE)**

WHEREAS, there is an infrastructure project funded through the **20% Development Fund 2022** to be undertaken by the Provincial Government of Oriental Mindoro for the **Concreting of Road at Malitbog Bongabong, Oriental Mindoro (Concreting of Road: PCCP: L of PCCP=147.00m, W of PCCP=4.00m, T of PCCP=0.23m, Thk 201=0.20, SHOULDER: Shoulder B/S 0.50m)**;

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2022-095) in PhilGEPS Website on **March 02, 2022** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Concreting of Road at Malitbog Bongabong, Oriental Mindoro (Concreting of Road: PCCP: L of PCCP=147.00m, W of PCCP=4.00m, T of PCCP=0.23m, Thk 201=0.20, SHOULDER: Shoulder B/S 0.50m)**;

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. MARCPHIL CONSTRUCTION

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **March 11, 2022**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

WHEREAS, during the opening of Bid on **March 11, 2022** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **MARCPHIL CONSTRUCTION** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:
